# PRIVATE PARTIES

## TERMS & CONDITIONS

### PRIVATE EVENT AGREEMENT

The Exchange agrees to provide the food, beverages, and services outlined in the attached event description, according to the following terms and conditions:

### PRE-EVENT DEPOSITS & PAYMENTS

A 50% deposit of the event's estimated total, along with a signed copy of this agreement, is required to reserve your event date and confirm services. The remaining balance of the estimated total is due on the day of the event. The Exchange reserves the right to cancel an event if payment deadlines are not met, if credit card charges are declined or disputed, or if checks are returned. After the event is completed, The Exchange will provide a final invoice, which may differ from the initial estimate depending on final attendance, additions, or changes.

### PRE-EVENT REVISIONS

All menu adjustments, drink package selections, and the final headcount must be submitted seven (7) days prior to the event. If a final headcount is not received by the deadline, the customer will be charged for at least the guaranteed guest count listed in the event description. If the plate count increases, the price per person will be updated based on the final number of guests. Menu or beverage changes requested after the deadline may or may not be accommodated, depending on availability. Any additions or removals made after this agreement is signed will require a re-signed updated contract.

### SERVICE CHARGE

A 20% service charge will be applied to all food and beverage totals. Service charges for third-party contracted services (if applicable) cannot be added to the final invoice and must be paid directly to the external vendor.

# PRIVATE PARTIES

## TERMS & CONDITIONS

### POST-EVENT FINAL INVOICE & ADDITIONAL FEES

The customer will be billed for the allotted event time stated in the attached event description. If the event extends beyond the scheduled time, additional hourly charges will apply. The customer will also be billed for the number of plates agreed upon in the event description. If the final plate count exceeds the guaranteed amount, the customer will be charged for all additional plates. Any missing or damaged equipment or property belonging to The Exchange or any approved third-party vendors will be billed to the customer.

### CANCELLATION POLICY

**The following cancellation fees apply:**

- 21 days before the event: 50% of the deposit, plus tax
- Inside 21 days before the event non-refundable deposit, plus tax

### OUTDOOR EVENTS

All outdoor bookings at The Exchange are reserved on a “rain or shine” basis. In the event of bad weather, it is the customer’s responsibility to relocate the event indoors or secure a covered outdoor area (e.g., tent rental). Additional tent or equipment rental fees will be billed to the customer. If the customer chooses to cancel due to weather, the standard cancellation policy applies, including deposit forfeiture.

### VENDORS

Vendor services (such as live entertainment, DJs, photo booths, etc.) must be finalized seven (7) days prior to the event. Adjustments after this deadline cannot be guaranteed. If contracted third-party staff or vendors are required to stay longer than scheduled, the customer will be billed for the additional time at the vendor’s rate.

### SAFETY REQUIREMENTS

The customer, along with all employees, guests, and invitees, must comply with all applicable safety laws, regulations, and instructions provided by The Exchange for the duration of the event.



# PRIVATE PARTIES

## TERMS & CONDITIONS

### LIMITATIONS ON DAMAGES

Neither party shall be held liable for failure to perform its obligations under this agreement when such failure is caused by an act of God, war, civil disturbance, strike, or any other force majeure event beyond the party's control, provided that reasonable measures are taken to mitigate the impact. In these situations, the customer's pre-event deposit(s) will be refunded. However, if a force majeure event occurs five (5) days or less before the event date and the customer must cancel, the customer is responsible for all actual costs incurred in preparation for the event, including but not limited to food, beverages, staffing, and rentals. The Exchange may retain all or a portion of the pre-event deposit(s) to cover these expenses. Under no circumstances shall The Exchange be liable for any speculative, consequential, punitive, or exemplary damages of any kind. The customer expressly waives any rights to such damages arising from event cancellations, service interruptions, or any breach or default under this agreement.

### RELEASE & INDEMNITY

The customer agrees to release and waive any claims against The Exchange, including its agents, employees, contractors, vendors, and officers ("Indemnified Parties"), for any injury, death, damage, or loss to persons or property occurring in connection with or incidental to services rendered under this agreement—even if caused in whole or in part by the negligence (whether sole, joint, or concurrent), gross negligence, strict liability, premises liability, willful misconduct, or breach of contract by the Indemnified Parties. The customer further agrees to defend, indemnify, and hold harmless The Exchange and all Indemnified Parties from any and all claims, losses, damages, liabilities, causes of action, suits, and expenses—including court costs and attorneys' fees—arising out of or connected with the event, including the actions or omissions of the customer, their employees, agents, licensees, guests, caterers, or third-party vendors. Such indemnity applies to the consequences of the Indemnified Parties' own culpable conduct or liability, including but not limited to:

- (a)** negligence, gross negligence, strict liability, premises liability, product liability, willful or malicious conduct, breach of contract, and actions in equity, whether such conduct was the sole, proximate, or producing cause of the claim, or whether it occurred jointly or concurrently with the culpable conduct of the customer or any other individual or entity; and
  - (b)** the consequences of the customer's own culpable conduct or liability in connection with the event, regardless of whether such conduct was the sole, proximate, or producing cause of the claim.
- Any person signing this agreement represents and warrants to The Exchange that he or she is duly authorized to sign on behalf of the customer and legally bind the customer to this contract.

This contract will only be honored if it is signed and returned with the required credit card deposit within 5 days from the time and date printed on this document. If The Exchange does not receive the client's signature, credit card information, and full deposit within that timeframe, the event date may be released to another party, and the terms outlined above may be subject to change.
